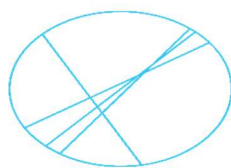

PAST EXPERIENCE OVERVIEW

ROBOTIC PROCESS AUTOMATION: DHS (HQ, FEMA, ICE)

DHS HQ - provided program management and enterprise architect support services to institute **DHS Robotic Process Automation (RPA) Working Group (WG)**. DHS RPA WG is a department-wide RPA Community of Practice (CoP), which comprises members from 12 DHS components (USCIS, USCG, CBP, CISA, FEMA, USSS, TSA, MGMT, S&T, I&A, OPS). It was designed to rapidly accelerate the adoption of RPA technology across DHS community. DHS RPA WG partners with GSA Federal RPA CoP and leads its Governance and IT platform practices. The WG partnered with CTO on RPA Technical Reference Model, Security (OCSO) on ICAM (Identify, Credential and Access Management) for Non-Person Entity certificates, and Procurement (OCPO) on strategic sourcing vehicle for emerging technology.

DHS FEMA – provided program management, software development support to establish OCFO RPA. Deployed “Agency’s First” production robot within 10 months. FEMA OCFO leverages RPA program and **Agile (Scrum/Kanban)** to automate routine financial business process and identify financial control deficiency that improves financial data accuracy, productivity, compliance, and provides deeper assist insight to prevent financial fraud. Provided fraud analytics plan and “Bots-as-a-Service” framework to COVID-19 Funeral program. Received **FEMA 2022 Administrator’s Award – Excellent in Innovation**.

DHS ICE – provided program management, software development, business process transformation support services to stand up OCFO RPA program. Deploying “DHS First” enterprise RPA multi-tenant platform with Authority to Operate (ATO) at DHS GovCloud environment. Received **ICE 2021 Leadership in Innovation Award**.
